

# **Student Learning Outcomes Assessment Committee Charter**

## **Purpose:**

The Cochise College Student Learning Outcomes Assessment (SLOA) Committee is responsible for promoting a culture of continuous program improvement and facilitating data-driven improvements that enhance the learning, development, and success of students while aligning with the vision, mission, and values of Cochise College.

# **Committee Objectives:**

- Facilitate and coordinate assessment activities for academic programs, including co-curricular activities.
- Review and implement rigorous assessment tools, best practices, and protocols to ensure consistency and sustainability in program assessment.
- Foster evidence-based decision-making through reviewing program assessment documentation and providing comprehensive feedback to programs to facilitate continuous program improvement.
- Collaborate and communicate with faculty, department chairs, administrators, and student representatives to foster an inclusive and rigorous assessment processes.
- Report assessment findings and recommendations regularly to the Cochise College community.

# **Committee Roles, Responsibilities & Activities**

- Engage in professional development activities as needed to understand the assessment process and the role of representatives on the SLOA committee members.
- Offer consultation and support for program assessment faculty and staff in the development, implementation, use, and dissemination of student learning outcomes assessments.
- Review and suggest revisions to program assessment documents, including curriculum maps, rubrics, assessment plans, and reports.
- Provide guidance and encouragement of assessment processes within their division, including disseminating assessment-related expectations, deadlines, and updates to all division members.
- Conduct research to support current assessment practices and stay informed of HLC accreditation standards to assist and support program assessment, including Assessment Day activities.
- Attend scheduled SLOA meetings prepared with feedback and questions.
- Provide suggestions for quality improvement of the assessment process.

#### **Committee Composition**

#### **Committee Chair:**

The SLOA chairperson will serve three consecutive years (one complete assessment cycle).



- Chairs meetings, sets meeting agendas, and ensures the smooth functioning of the committee through facilitating communication and collaboration among committee members.
- Oversees the implementation of program assessment processes and guidelines.
- Serves on the Academic Program Review Committee, as the SLOA representative.

## Leadership & Faculty Representatives:

 Members from each academic division actively participate, contribute expertise, and support program assessment discussions and activities

#### **Accreditation Liaison Officer:**

 Collaborate with the committee to ensure compliance with accreditation standards and requirements.

### **Student Services Representative:**

Advocate for student perspectives in program assessment discussions.

# **Assessment & Curriculum Specialists:**

 Contribute expertise in assessing student learning outcomes and continuous program quality improvement through best practices and procedures, providing training, professional development, and additional resources.

#### **Meeting Frequency:**

The committee shall meet regularly, at least once a month during the academic year, or as determined by the committee members with additional meeting(s) scheduled to address specific assessment initiatives or emerging needs.

# Reporting:

- The committee shall provide regular reports to the relevant college departments,
  administration, and faculty regarding assessment activities, findings, and recommendations.
- The committee shall maintain appropriate documentation and records of assessment processes, outcomes, and improvements.

#### **Amendments:**

This charter may be amended or revised as necessary with the approval of the committee members and relevant college authorities.
