

Identification Requirements for Proposition 300

A.R.S. 15-1802.01

The following is a list of acceptable documents for proving a student's citizenship status for purposes of determining eligibility for in-state tuition. Documents may be emailed to: admissions@cochise.edu, mailed, or submitted in person to the Admissions and Registration Office. Final residency decisions for tuition purposes will be made in accordance with A.R.S. 15-1801 and regulations of Cochise College policy.

List A – Only one document from List A is required by a student.

1. Arizona driver's license or an Arizona non-operating identification card issued after October 1, 1996.
2. Driver's license, instruction permit or non-operator ID issued by another U.S. state or possession that verifies lawful presence. Those must be dated 2000 and beyond. States for which licenses are not acceptable are Hawaii, Maryland, Massachusetts, Michigan, New Mexico, North Carolina, Oregon, Texas, Utah, and Washington, as these states do not verify lawful presence in the U.S.
3. Driver's license or non-operating identification license issued by another state or outlying possession of the United States if the license indicates on its face that the person has provided proof of United States citizenship.
4. U.S. Passport (unexpired or expired)
5. Certificate of U.S. citizenship (Form N-560 or N-561)
6. Certificate of Naturalization (Form N-550 or N-570)
7. Unexpired Foreign Passport with an I-551 stamp
8. Unexpired Foreign Passport indicating nonimmigrant visa status, and such visa status either has not expired or has been extended
9. Form I-94 verifying current status as "Refugee," "Asylum Granted," "Parolee," or "Cuban-Haitian Entrant"
10. Permanent Resident Card with photograph or Alien Registration Receipt Card with photograph (Form I-151 commonly referred to as a "Green Card" or Form I-551)
11. Unexpired Temporary Resident Card (Form I-688)
12. Unexpired Employment Authorization Card (Form I-688A)
13. Unexpired Reentry Permit (Form I-327)
14. Unexpired Refugee Travel Document (Form I-571)
15. Unexpired Employment Authorization Document issued by Department of Homeland Security that contains a photograph (Form I-688B)
16. U.S. Military card or draft record
17. Military dependent's ID card
18. U.S. Coast Guard Merchant Marine Card

List B and C – One document from both List B and List C is required by a student.

List B

1. Arizona driver's license or an Arizona non-operating identification card issued before October 1, 1996.
2. Driver's license or identification card that does not indicate that the person has provided proof of United States citizenship issued by a state or outlying possession of the United State provided it contains a photograph or information such as a name date of birth, gender, height, eye color and address.
3. Voter registration card
4. Native American tribal document (indicating identity of the student)
5. Driver's license issued by a Canadian government authority

List C

1. United States social security card issued by the Social Security Administration
2. Certification of Birth Abroad issued by the Department of State (Form FS-545 or Form DS-1350)
3. Original or certified copy of a birth certificate issued by a state, county, municipal authority or outlying possession of the United States bearing an official seal
4. Native American tribal document related to the student
5. U.S. Citizen ID Card (Form I-197)
6. Identification Card for use of Resident Citizen in the United States (Form I-179)
7. Unexpired Employment Authorization Document issued by Department of Homeland Security (other than those listed in List A)
8. Other documentation indicating lawful immigration status
