1.01 Call to Order

1.02 Pledge of Allegiance

1.03 Adoption of Agenda

1.05 Standing Reports

1.05.1 Representative to the Arizona Association of Community College Trustees (AACCT)

Mrs. Strain reported the Arizona Association of Community College Trustees would meet in February, at which time they will hold elections for new leadership. Association of Community College Trustees is holding a regional Governance Leadership Institute (GLI) in April at Pima Community College; Mrs. Strain and Lloyd Hammonds will participate in a panel discussion during the event.

1.05.2 Senate

The Governing Board reviewed the Senate Report for November 2019 and accepted as submitted.

1.05.3 Student Government Association (SGA)

Students were taking final exams, so the Governing Board reviewed the written Sierra Vista Student Government Association fall semester report, and accepted as submitted.

1.05.4 College President

Dr. Rottweiler thanked the Board for attending the groundbreaking ceremony for the new Automotive Technology Building.

Legislative Update

- FY'2021 Budget Request was submitted to the Governor's Office on September
 There is no action at this time, just waiting for the Governor's State of the State Address in January.
- Based on preliminary formula funding, Cochise College anticipates receiving an additional \$66K in M&O, \$18K in STEM, and \$622K in Equalization (assessed valuation).
- President's Legislative agenda is the reinstatement of additional rural money as an ongoing formula amount.
 - FY2020 \$3.14M allocations: \$2.4M for Automotive Technology Building;
 \$500K for Greenhouse; and \$500K for Virtual Reality Developer Program
- Legislative Visit on October 31, Cochise College and Fort Huachuca hosted eight legislators for a tour and discussion regarding the college developing a virtual reality program; feedback received is very positive. Senator Gowan is working hard to restore \$14.2M for all rural community colleges.
- Cochise Day at the Legislature February 3; the president will take four to six students to the state capitol
- Arizona Community College Day at the state capitol February 19 (showcase programs from Cochise College)
- Voter Initiatives **nothing new**
- Participated in a Rural Caucus panel during the American Legislative Exchange Council (ALEC) conference on December 4 at the request of Representative Becky Nutt. Also participating on the panel were Tony Boone, City of Sierra Vista Economic Development Manager, Geoff Oldfather, Arizona G&T, Keith Watkins, Arizona Commerce Authority.

Master Facilities

- Groundbreaking for new Automotive Technology Building
 - Permit received to bring loads of dirt into the college off of Giulio Cesare
 Ave. to keep the trucks off the campus drive; roughly 550 more loads
- Greenhouse for Agriculture
 - The building is purchased but is delayed in delivery. Spring semester classes have been adjusted to accommodate the late delivery.
 - Foundation to be poured before Winter break

New Initiatives

- Updates to the Governing Board's suggested initiatives for this fiscal year include:
 - Jenn Wantz is now the Director of Community Relations

- Douglas Campus and Community Relations Manager job posting out soon for hire in early February; position will report to Ms. Wantz.
- o Solar Trough Repair
 - Waiting for the final report from Pueblo Mechanical; due December 20th to include energy efficiency report
- Health-related program expansion. Under Dean Lakosil's leadership, the administration will meet with Pima Community College on December 19, to discuss consortium programs to expand offerings in Cochise County; Shared programing.

Student Housing

- During the President's Forum with Student Government Association and campus students held in September, students expressed the need for Student Housing on the Sierra Vista Campus
 - students having difficulty securing rental properties
 - o wait-time for rental housing is 90 to 120 days
 - hosted a meeting with the representatives from the City of Sierra Vista, Frank Moro from First West Properties, and representatives from Phoenix Opportunities Zone professionals to discuss rental housing shortages and possible funding resource projects
 - requesting to schedule a work session in the new year to discuss options and board wishes. Sierra Vista housing could be a destination location for specific programs (nursing, VR, Cyber, etc.)

Dr. Verlyn Fick, Executive Vice President/Provost, included in the board packet a copy of the Higher Learning Commission (HLC) Assurance Review Report, which is a four-year review of the college's ten-year approved HLC accreditation report. The college submitted the report to the HLC on December 2, 2019.

Dr. Fick recognized and thanked employees who helped prepare the year-four review report, which included 85 percent of the material from the initial accreditation report along with changes or updates to existing data, and the addition of new arguments.

The HLC team will review the report, request clarification or additional supporting material, and then send the report to their institutional actions committee. The college anticipates receiving a report confirming the college is on track following the ten-year approved accreditation assurance review or noting if further correctional action is needed.
