# 1.05.4 College President

Dr. Rottweiler began his report recognizing the SGA members for their continued participation and leadership through difficult times with COVID. He then provided the board with updates; highlights included:

## Legislative Update:

- Governor's Budget was released on Friday, January 14. The budget recognized
  that community colleges make a difference in the state. The budget included full
  formula funding, an additional \$10.8M to restore STEM and Workforce funding
  for Pima and Maricopa and an additional \$7.0M to the 10 Rural Colleges.
- This is a recommendation only. Needs to go through the Legislative process.
- Should the budget submission be recommended for funding, Cochise would receive:
  - o An increase of \$678,200
  - Rural Aid (one-time)—\$1,757,100
- On Wednesday, January 26, the community college CEO's met with Governor Ducey at the Arizona Commerce Authority Building for a press conference and briefing on workforce initiatives in each of the districts. He was interested in what the colleges are doing, plan to do, and other exciting initiatives. Dr. Rottweiler shared the happenings in Cochise County to include the new Port of Entry and the work the college is doing:
  - The First Responder Academy to include wildland fires and EMT/Paramedicine.
  - The changing mission sets at Fort Huachuca including the emphasis on testing and a desire for a Workforce Accelerator for soldiers transitioning from service to prepare them for civilian work. It was well received.
- Arizona Community College Coordinating Council (AC4) January 26
  - Met with Senator Gowan.
- March 22 Cochise College day at the Capitol. Four students along with Jennifer Wantz and Crystal Wheeler will join for the day. Students will stay overnight to participate in the Community College day in the Rose Garden on the 23. Students will also participate in a tour of the Capitol and meet with key legislators.
- Bills of Interest:

  - H2276–AG to investigate at the request of the Legislature

- o H2447, H2414, S1123–Firearms on college campus
- o S1374–EL bill for Community College Expenditure Limitation

# COVID-19 Updates:

- Administration will continue to monitor the COVID numbers. Cochise County continues to be in the high transmission category. Currently, 68.9% of the population five years/older in Cochise County are vaccinated. The college has 30 open cases.
- In continuing efforts to mitigate COVID-19, the college will host a COVID vaccination POD in both Sierra Vista and Douglas on February 10. The clinic is open to students, faculty/staff, and the community.

## Facilities Update:

- First Responders Academy
  - 5 Architectural Firms responded to an RFP that was due January 24. The administration is currently interviewing finalists.

#### General Comments:

- Gave thanks to the board for their time on January 28 for the Board Retreat.
   Administration is working through the process on the board's policy recommendations.
  - o Code of Conduct should replace the current Code of Ethics policy 204
  - Board Chairpersons Role Policy 202 can continue to use Board Chair rather than Board President.
  - The Board Assessment will be attached to Policy 201 Board Responsibilities as tool with the language "using the assessment tool as determined by the Board Chair"
  - The revised policies will be presented to the board for first read next month, then back for a second read and approval the following month.
- Adult Education Briefing: The Board requested a briefing from the new Adult Ed Director, Peter Hooper on his vision for the program. That presentation is scheduled in the coming months. In preparation, Barbara Richardson will prepare an update on the program. In December Adult Education received a memo of concern regarding decreased enrollment and measurable gains. This was due primarily to COVID and remote learning. In collaboration with the Arizona Department of Education (DE) a Corrective Action Plan was developed. That Plan was accepted by DE on January 21, 2022.
- Cochise College was invited to participate in an EDA Good Jobs Challenge Grant
  with six other border colleges in Texas. The Challenge Grant will focus in
  locations with Ports of Entry (land and Sea) in the areas of Aerospace and
  Defense. Many thanks given to Dr. Fick and Celia Jenkins for their hard work with
  gathering and submitting all the required information.
- The Arizona Community Colleges are submitting a grant proposal for advanced manufacturing.
- An invitation has been sent to Sandra Watson from the Arizona Commerce Authority for a visit to Fort Huachuca related to a Workforce Accelerator. An invitation will also be sent to the Governor's Office once a date is established.
- Held meetings with American Leadership Academy (ALA) a charter school operator in Cochise County. This is a group the college has worked with in the past to bring students onto campus for advanced coursework, they've requested to lease space to better facilitate their 9-12 programming. If the college is interested in doing this, it would allow their students to take better advantage of

college level coursework, including CTE programs should the board be comfortable with administration pursuing a partnership. The college would not be the sponsor and the board would not be required to do anything, the company would lease space on the Sierra Vista Campus. This would be an opportunity for participating students to potentially receive their high school diplomas at the same time they receive their associate's degree.

- Dean Beth Hill and Dr. Dana Horne provided Legacy Foundation of Southeast Arizona an intent to apply for grant dollars this budget year for a Behavioral Health Technician program. The program would be a one semester, 13 credit program, preparing students to work in an entry level position. The job demand is high.
- On January 19 through the 21, Dr. Davis and Dr. Rottweiler participated in the Cochise Combined Trust Annual Renewal Meeting and Retreat. The college Health Insurance Trust with the County and Central Arizona College is in good condition and rates remain very stable. This continues to be a good option for the college.
- On January 25, Mr. Jennings, Mr. Matt Walsh, and Ms. Alanna Riggs hosted the college's leadership team on Fort Huachuca for a tour and briefing; it was an outstanding day. The visit was recognized by the Army and the Department of Defense.

- David Luna and Dr. Rottweiler hosted a kickoff meeting for the development of a technology consortium. Cochise was awarded a grant to establish a shared services technology consortium between six Arizona Community Colleges.

# Questions/Comments:

Dr. Rottweiler addressed questions and concerns from board members regarding 9-12 grade students on the campus noting that the college currently has high school students on campus taking classes. If space is leased to ALA, the freshmen and sophomore students would be in classrooms with aides and paraprofessionals while they receive their curriculum virtually in a hybrid format. Once students are prepared for college-level work, they will be enrolled in college classes such as English 101, welding, automotive, fine arts, Spanish 101, etc.

Administration will continue pursuing the opportunity and will report back to the board with more details including how the charter school is working with county school districts. ALA has already spoken with the Sierra Vista Unified School District.

Mrs. Strain asked that appropriate notification be distributed and given to board members before marketing of the opportunity.

# 3.02 Cochise College Foundation Report

Denise Hoyos, Executive Director of the Cochise College Foundation, provided an update to the Governing Board; highlights include:

Charitable support from the community provided:

- 1,068 scholarships totaling \$645,266.50 to 842 students in 2020-2021. Awards ranged from \$100 to \$3,250; the average award was \$604.
- \$33,327 in support for supplies and equipment to college academic programs

## Other Progress:

- Investments grew by \$3.6 million and total assets at the end of FY21 totaled \$17.7 million
- The foundation exceeded its \$100,000 goal, when gifts not related to an event are included.
- Proceeds from the August sale of Project House #3 are helping with Project House #4.

#### In addition:

- 400 donors made gifts in 2020-2021
- The donor retention rate toped 56 percent, about 10 percent above the national average.

# 3.04 Investment Report

Dr. Wendy Davis, Vice President for Administration and Ms. Debbie Craig, Director of Finance/Controller, presented highlights of the Cochise College annual investments.

A Quarterly Investment Report was distributed and highlights include:

- With the Investment Committee's advice, administration will seek advice from investment advisors on opportunities the college may have to increase returns.
- Will review opportunities to expand longevity extending maturity dates, as well as some additional investment platforms.
- An ebb and flow of investments as funds are invested and maturing for specific projects then expensed out at the completion of the project; such as the Automotive Building
- Currently just under \$20M invested in anticipation of the First Responders Academy project over the next two years.
- Policy Compliancy each quarter ensuring safety of the principal liquidity and return on investment.
- No cash flow issues with regular deposits from local property taxes, tuition, and the state.
- Working with investment advisors to ensure investments are made appropriately on behalf of the college
- Credit quality rating AAA

  - Announced that Jennifer Lakosil is the temporary chief nursing officer at Copper Queen Community Hospital.
  - Discussed a Conference he attended regarding Ransomware; noting the information shared was very eye opening. Topics included the need for a recovery plan, reestablishing trust of vendors, hold drills at least once a year, have a plan should the college if the college shut down.
