1. GENERAL FUNCTIONS

1.01 Call to Order

Mr. DiPeso called the meeting to order at 6:00 p.m.

1.02 Pledge of Allegiance

Mr. DiPeso led the Pledge of Allegiance.

1.03 Adoption of Agenda

The agenda was adopted as published with no adjustments.

1.04 Citizen's In-person Interim

There were no requests to address the Board.

1.05 Standing Reports

1.05.1 Representative to the Arizona Association of Community College Trustees (AACCT)

Mr. Quinn provided an AACCT update reporting that a meeting was held on February 23, 2022 via zoom with all community colleges represented. Kristen Boilini provided a report discussing the concealed carry bill; House Bill 2691, which adds additional dollars for nursing, and has moved to the Senate; and House Bill 2685, which adds additional dollars for adult population training, and has moved to Senate. There was also a discussion on the

Goodwill Bill, where the agency would be allowed to build Excel Centers to provide training for GED programs. Maricopa.

Also noted: Community College Day is on March 23, at the Capitol; there will be a joint meeting in August between the AACCT and AC4; and an interesting stat that came is that over 700,000 adults in Arizona do not have a high school diploma.

1.05.2 Senate

The Governing Board reviewed a written Senate Report, and accepted as submitted.

1.05.3 Student Government Association (SGA)

The Governing Board reviewed a written Student Government Association Report, and accepted as submitted.

1.05.4 College President

Dr. Rottweiler also recognized the SGA students then provided the board with updates; highlights included:

Legislative Update:

- The Governor's budget included full formula funding, \$10.8M to restore STEM and Workforce funding for Pima and Maricopa and \$7.0M to the 10 Rural Colleges. The initial budget from JLBC does not include the restored STEM funding for the Urbans or the one-time for the rural districts. Negotiations are happening now behind closed doors.
- This is a recommendation only. Needs to go through the Legislative process.
- On March 15, presenting at Rural Caucus. The topic will be Arizona Healthcare Workforce:
 - Needs and Opportunities. It is being facilitated by the Arizona Hospital and Healthcare Association. Daniel Corr, Chair of AC4 and president of Arizona Western Community College and Dr. Rottweiler will address rural healthcare issues including the shortage of nurses and clinical hour providers. They will be joined by Dr. Magu, Chief Medical Officer at Yuma Regional Medical Center and Julia Strange, Chief Executive Officer, Benson Hospital.
 - This is response to HB2691–Healthcare Workforce; Grant Opportunity
 - Appropriates \$15 million from the general fund in each of FY2022-23 through FY2026-27 to the Department of Health Services (DHS) for the Arizona Nurse Education Investment Program, which is established to increase the capacity of nursing education programs in Arizona. DHS is required to allocate monies to the Arizona Board of Regents and community college districts based on the number of nursing students graduating in FY2021-22. Pay for faculty.
 - Appropriates \$27 million from the general fund in each of FY2022-23 through FY2026-27 to DHS for the Nurse Clinical Rotation and Licensed Nurse Training Program, which is established to expand the capacity of preceptor training programs at health care institutions for nursing students and licensed nurses. DHS is required to develop a grant institution for nursing students and

licensed nurses. DHS is required to develop a grant program to distribute the monies to licensed health care institutions to expand or create clinical training placements for nursing students and licensed nurses.

- March 22, hosting Sandra Watson, CEO, Ken Burns, CFO, and Brian Shurman, CIO, from the Arizona Commerce Authority; tied to Workforce Accelerator.
- March 22, Jenn Wantz and Crystal Wheeler will be in Phoenix with four students working the legislature with the president joining them for dinner that evening and then a tour of the Capitol and meet with Senator Gowan on March 23.
- March 23, the students and staff will participate in the Community College day in the Rose Garden. Cochise College will be showcasing Aviation (flight simulator) and Nursing (ambulance and live feed of the virtual cadaver).
- Bills of Interest:
 - H2447, H2414, S1123–Firearms on college campus
 - S1374–EL bill for Community College Expenditure Limitation through the house and awaiting vote.
- Redistricting: The Arizona Independent Redistricting Commission has approved Congressional and Legislative Districts.
 - These changes require some small adjustments to the Cochise College Districts.
 - Required to move 4 address points, with 4 registered voters from District 5 (Mr. Nelson) to District 2 (Mr. Hudgins).

Facilities Update:

- First Responders Academy
 - There is an agenda item this evening for architectural services. There are some concerns about pricing changes based on inflation and supply chain issues.

Initiatives:

- Stackable Credentials in Allied Health
 - Phlebotomy Tech (65 hours/non-credit). Started in January with 12 students. They have completed the didactic and lab and are into their externship to obtain the required 50 successful venipunctures and 10 successful capillary draws. These are students wishing to enter the medical field. We also have a number of current MA students working on the certification as well. Plans are to offer these courses in Douglas and Benson this fall. Additional Associate Faculty have been hired in this area.
 - EKG Tech (30 hours/non-credit) will begin March 15th. Currently there are 7 students enrolled. Most of the students are looking to get into the field but there is at least one student who is a working MA seeking the certification at the request of their employer.
 - The medical billing and coding program has been approved by the Higher Learning Commission and the Department of Education; it is eligible for federal financial aid, and the college will be offering the one year program beginning in August.

Dr. Rottweiler has had direct communications with Tucson Sector Chief Modlin and Senator Mark Kelly. On Tuesday, March 1, he met with a team from the Douglas Station, including new Patrol Agent in Charge, Jon Scanlon. Based on calls, effective that morning, Boarder Patrol will apprehend on the college campus at the request and approval of the college. All of this is in response to the memo from Secretary Mayorkas, Guidelines for Enforcement Actions in or Near Protected Areas. While administration has the immediate issues under control, they have increased security on the campus, provided information to on-campus residents, and established reporting protocols. The Herald has requested an interview on March 14.

A minimum of two credits is required to be considered an ALA student and the program, if approved, would start in August 2022.

2.02 Faculty Emeritus

2.03 2022-2023 Student Tuition Schedule

The administration requested the Board adopt a motion to approve the tuition schedule for FY2023, as presented.

Dr. Verlyn Fick, Executive Vice President/Provost, and Dr. Wendy Davis, Vice President for Administration, presented a tuition and fees schedule, some proposed changes include:

Tuition Fee Changes:

- \$1 increase per credit hour for in-state
- \$1 increase per credit hour for online (all online rates will match the in-state or out-of-state rates)
- \$2 increase per credit hour for in-state nursing and LEO Police Academy
- Move all active military tuition to the approved in-state rate (\$92 proposed)
- \$2 increase per credit for out-of-state (1-6 credits)
- \$10 decrease per credit for out-of-state (over 6 credits)
- \$29 decrease per credit for out-of-state nursing
- \$29 decease per credit for out-of-state police academy LEO
- \$87 increase per credit for online out-of-state (to match the out-of-state rate of \$250)
 - The current cohort of students will remain at the \$163 with the \$87 being covered as a scholarship for the next two years they will have a chance to complete their degree at the \$163 rate.
- \$71 decrease per credit for dual enrollment making the new rate \$20

The increased fees would generate approx. \$80,000.

On-Campus Living – Some Fee Changes (helping to off-set inflation costs)

- \$50 increase for room rate (17-week semester)
- \$2 increase for laundry fees
- \$30 increase for combined meal plan and housing with 12-14 credit hours
- \$59 increase for Professional Pilot room rate (21-weeks)
- \$33 increase for Professional Pilot combined meal and housing plane
- Added two-bedroom apartment availability at 860 per month
- \$20 increase in monthly single room rate

There were no changes to the miscellaneous fees.

After much discussion led by Mr. Quinn regarding reasons for not wanting to increase tuition rates, the board was presented with two tuition fee options:

- Option A \$1 per credit hour increases
- Option B No tuition increases with the exception of increasing the online out-of-state rate to match the current out-of-state rate of \$250, which is an increase of \$87.

Mr. Hudgins moved to approve option A, there was no second so the motion failed.

Mrs. Strain moved, and Mr. Quinn seconded a motion to approve Option B. The Governing Board approved with members, David DiPeso, Jane Strain, and Tim Quinn voting aye and Don Hudgins voting no. MOTION CARRIED.

2.04 Security Camera Project – Douglas Campus

The administration requested the Governing Board adopt a motion to authorize the college president or his designee to approve the estimate of \$297,312.33 to complete the security camera project on the Douglas Campus.

Mr. Quinn moved and Mr. Hudgins seconded a motion authorizing the college president or his designee to approve the estimate to complete the security camera project on the Douglas Campus. There was no further discussion. The Governing Board unanimously approved with members, David DiPeso, Don Hudgins, Jane Strain, and Tim Quinn all voting aye. MOTION CARRIED.
