#### **Description of necessary first aid measures**

Special protective actions for fire-fighters

#### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. ### **Appropriate engineering** controls
