Personal precautions, protective equipment and emergency procedures: ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Keep unauthorized personnel away. Sweep up and place in a clearly labeled container for chemical waste. Avoid dust formation. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spills for later disposal.

Notification Procedures:

Dike for later disposal. Prevent entry into waterways, sewer, basements or confined areas. Stop the flow of material, if this is without risk. Inform authorities if large amounts are involved.


