Section 4 First Aid Measures

Emergency and First Aid Procedures

Steps to Take in Case Material Is Released or Spilled:

Exposure to the spilled material may be severely irritating or toxic. Follow personal protective equipment recommendations found in Section 8 of this SDS. Personal protective equipment needs must be evaluated based on information provided on this sheet and the special circumstances created by the spill including; the material spilled, the quantity of the spill, the area in which the spill occurred, and the expertise of employees in the area responding to the spill. Never exceed any occupational exposure limits. Ventilate the contaminated area. Isolate area. Keep unnecessary personnel away. Remove soiled clothing and launder before reuse. Avoid the generation of dusts during clean-up. Reduce airborne dust and prevent scattering by moistening with water. Ventilate the area by opening door and/or turning on fans and blowers. Vacuum or sweep up material and place in a disposal container. Neutralize spill with a weak acid such as vinegar or acetic acid. Use an inert absorbent such as sand or vermiculite. Place in properly labeled closed container.

Section 7 Handling and Storage

Handling: Do not breathe dust/fume/gas/mist/vapors/spray. Wash thoroughly after handling. Wear protective gloves/protective clothing/eye protection/face protection. Keep container tightly closed in a cool, well-ventilated place. Avoid contact with skin and eyes. After contact with skin, take off immediately all contaminated clothing, and wash immediately with plenty of water. Do not breathe dust. Use only in well-ventilated areas.

Storage: Store locked up. Keep container tightly closed in a cool, well-ventilated place.

Storage Code: White - Corrosive. Separate acids from bases; separate oxidizer acids from organic acids.
