### 1. GENERAL FUNCTIONS

#### 1.03 Adoption of Agenda

The agenda was adopted as published with no modification.

# 1.05.1 Representative to the Arizona Association of Community College Trustees (AACCT)

Mr. Quinn, AACCT representative, did not have an update.

#### 1.05.2 Senate

A Senate report was not provided as the institution is in summer session.

#### 1.05.3 Student Government Association (SGA)

A Student Government Association report was not provided; students on summer recess.

# 1.05.4 College President

Dr. Rottweiler provided the board with updates; highlights include:

Legislative Update:

- Reviewed 2022 End of Session Report
  - Community College FY'23 Funding (HB2862)
  - Budget approved and signed by Governor prior to shut-down
    - \$8,771,400 for Equalization
    - \$4,230,000 for M&O
    - \$895,200 for STEM/Workforce
    - \$5,267,500 for Rural Aid
    - \$6,250,000 Rural (one-time) for indoor shooting range and burn tower
    - Total \$19,164,100
  - Executive \$30M in Federal funding for Arizona Workforce Accelerators at Community Colleges.
    - Cochise College submitted a proposal to Arizona Commerce Authority (ACA)
  - STEM Pima and Maricopa back in for funding
  - Adult Education Package Adult education workforce bill. A joint effort by the community colleges, Goodwill, and Graduation Alliance. Each of the three programs will receive roughly \$6M per year over a three-year period.
  - Nursing Workforce Expansion \$15M general fund appropriation each year for the next three fiscal years (a total of \$45M) for community colleges and universities to expand nursing education programs.
    - Additionally, \$27M in ARPA funds dedicated to expanding student access to clinical opportunities
    - \$5M ARPA funds for behavioral health training pilot programs at Maricopa and Northland Pioneer
  - Temporary relief for Expenditure Limitations not a concern for Cochise, but it is significant for other institutions
  - CTED Associates Degrees gives CTEDs the authority to confer associate's degrees in workforce shortage areas
- All in all, it was the finest legislative year in decades! Rural college continue to be recognized for their impact on their counties and communities.
- Legislative Session at the AC4/AACCT Retreat in Flagstaff on August 24-25
   Mr. Quinn, Ms. Wheeler, and the president will attend
- The FY'24 Budget Submission is due September 1 Dr. Wendy Davis is the chair of the CBO's group and heading the charge.

Facilities Update:

- First Responders Academy
  - The engineers for the Chiricahua Housing Project believe there is major shoring up that would be required for that facility. Based on the anticipated costs, administration recommends the demolition of that facility. The unexpected change requires a revisit of strategic initiatives, which includes reevaluating the location of the First Responders Academy and also the timing of athletic expansion.
- Roofing Projects: Aviation Building and DiPeso Library (October start)
- Artificial Turf on Bo Hall Field (November/December start)

- Well Project (Winter Break Start)
- Welcome Center on Douglas Campus awaiting plans and materials

## Initiatives:

Over the past month a number of initiatives have been moved forward:

- Strategic Initiative #1 Equitable Access to Technology
  - \$8.2M grant in partnership with Cox Communications and the City of Douglas to bring fiber to the Douglas Campus.
- Strategic Initiative #4 Determine additional programs and pathways to enhance CTE by high school students
  - Early College Initiatives: Partnership with American Leadership Academy-Virtual, and Dual Credit offerings at Buena High School taught by Cochise faculty. Offerings include: CNA, four math and English, and one Chemistry (at the college for labs). The college is also offering CNA, home health aide, mental health, Amazon Web Services, Google Networking and Information Systems, HVAC, construction technology, welding, and automotive.
- Strategic Initiative #4 Determine additional programs and pathways to enhance Workforce Development
  - As part of the FY'23 Budget administration allocated dollars for the creation of a Workforce Accelerator in anticipation of the ACA approval. With the Board's approval on an action item, responsibility will be assigned to Mr. Karl Griffor as the Dean of Workforce Development. Karl will work to provide credit and non-credit workforce development opportunities in short and long-term training scenarios. From boot camp certifications in IT to CDL training to potential SkillBridge programming for transitioning soldiers.
  - The first CDL class has started with lots of interest for the next several classes.
- Strategic Initiative #4 Determine additional programs and pathways to enhance CTE
  - Adult Education IET programming the college is positioned well with the new funding.
  - Adult Ed is staffed and ready to roll under the leadership of Peter Hooper.
- Additional Allied Health Programming
  - Behavioral Health Technician Program the program has been approved by HLC, faculty hired, and students are enrolled
    - Surgical Technology Program in partnership with Pima Community College. The hope is to begin a satellite program in January.

# 2.03 Douglas Campus Chiricahua Hall Demolition

The administration requested the Governing Board approve a motion authorizing the College President or designee to sign the quote to Comprehensive Risk Services, LLC (CRS) in the amount of \$373,752.

Dr. Wendy Davis, Vice President for Administration, explained that weight of the second story is the issue with the soil conditions. The single level of the facility would not be demolished. She also responded to Mr. Quinn noting that the timeline is approximately four to five weeks and the students living in the dorms will be protected during the demolition process.

Mr. Quinn moved, and Mr. Nelson seconded a motion authorizing the College President or designee to sign the quote to Comprehensive Risk Services, LLC (CRS) in the amount of \$373,752. # 3.01 Communications

- Dr. Rottweiler received an email from Lynn Tincher-Ladner, President and CEO for PTK, informing him that Cochise College student, Kaelyn Edwards, had been selected to receive the StudyBuddy TEAS & HESI Prep award of \$300. StudyBuddy is an eLearning platform that provides completely asynchronous online courses that focus on conceptual understanding of material to help students achieve higher scores on exams.
