1. GENERAL FUNCTIONS

1.01 Call to Order

Mr. DiPeso called the meeting to order at 6:01 p.m.

1.05 Standing Reports

1.05.1 Representative to the Arizona Association of Community College Trustees (AACCT)

Mr. Quinn reported that the AACCT members met with the Arizona Community College Coordinating Council (AC4) during a joint retreat held on August 24-25. Discussions included a join briefing on legislative matters, and challenges with possible split in the House and Senate. In separate meetings, the trustees discussed legislative priorities to include future funding. In recognition of tremendous funding received last year, the trustees discussed providing evidence on what the money was spent on. Discussions also included hosting an all-trustees meeting in month of April to possibly be held in Tucson. All 52 trustees would be invited with topics such as trustee matters and open meeting laws; more information to come.

And that when he reports back to the board at the end of the year; his hope is that he serves the SGA well and that his peers appreciate him and what he did.

Mr. Hudgins and Mr. DiPeso expressed their appreciation for all that SGA does for students.

1.05.4 College President

Dr. Rottweiler began the report recognizing the SGA students. He then provided the board with updates; highlights included:

- LD 19 seems stable going into the general election. Senator David Gowan is running unopposed and is in line for a run at Senate President. In the House, incumbents Gail Griffin and Lupe Diaz are running against democrat Sanda Clark. The president has met with each of the candidates and believes the college is in good standing.
- The college hosted the Sierra Vista Area Chamber of Commerce's Meet and Greet for candidates running for federal, state, and local offices; it was well attended.
- Mr. Quinn, Ms. Wheeler and Dr. Rottweiler traveled to Flagstaff for the joint AC4/AACCT retreat. Some initial work was done on the legislative agenda. Expenditure limitation will continue to be a big part of the agenda as many

colleges struggle with spending capacity. Dr. Rottweiler suggested that the AC4 group look at a referendum in partnership with the school districts, the counties, and the town and cities to join together in changing the formulas, which were set in the 1980s.

Facilities Update:

- Douglas Campus
 - Security Camera Project
 - All new cameras installed
 - Some cameras still need to be connected to the network
 - Amer-X scheduled to return this week to complete connection
 - Gymnasium HVAC Unit being replacement
 - Both units have been installed
 - One unit is operational, but the other unit requires manufacturer programming to make operational (estimated in 1-2 weeks)
 - DiPeso Library Roof replacement
 - Materials are on-hand
 - Pre-construction walk-through scheduled for September 15
 - Project start date expected in October
 - Aviation Roof replacement
 - Most materials received, except some of the metal roofing components
 - Contractor delayed start date due to monsoon season
 - Pre-construction walkthrough once all materials have arrived and contractor work schedule is finalized
 - Project expected to start in the November-December time frame
 - Aviation Fabric Tent re-purposing for aircraft maintenance
 - Aircraft maintenance will be relocated to the smaller fabric tent in preparation for the roof replacement of the aviation building
 - HVAC unit installed
 - Electrical runs expected to be completed within 2-3 weeks to complete the project
 - Welcome Center
 - Waiting on Architectural drawings
 - Underground junction boxes and fire alarm panel manufacturing delayed
 - Expected construction start during the first week in December
- Sierra Vista Campus
 - Procurement Office build
 - Two new office spaces located in the Facilities Building
 - Most construction completed
 - Expected project completion end of the week
- Downtown Center
 - Memory Wall Shade Structure installation
 - Shade Sail support poles to be set this week
 - Sail installation planned for next week
 - Heating Boiler replacement
 - Original boilers were over 20 years old
 - New boiler is over 90% efficient and will result in significant reduction of natural gas usage
 - Both units are installed and operational
 - Energy Management Control System programming in progress

Initiatives:

- Strategic Initiative #4–Determine additional programs and pathways to enhance CTE by high school students
 - Through the Workforce Development under Dean Richardson and Dean Griffor, the college is offering Friday CTE courses to 56 students from around the county.
 - Students from Benson Digital, Bisbee, Bowie, PPEP Tech Sierra Vista, Saint David, Valley-Union, and Willcox are able to participate in Welding, HVAC, Construction, and Automotive.
- Strategic Initiative #4–Strengthen Current Practices and Seek to Implement New Programming—Bachelor's Degrees
 - The board packet contained an Academic Report related to Bachelor's Degrees offered at Community Colleges. It is the college's intent to keep this initiative in sight over the upcoming months as the college prepares for an anticipated start date of Fall 2024. As the Academic Report outlined, administration will bring to the board for their consideration two potential bachelor's degrees in November or December. A Bachelor's of Science in Nursing and a Bachelors of Applied Science in Leadership and Management. Beyond the work being done in curriculum development, work has been initiated in other support areas of registration, records, transcripts, financial aid, counseling and advising, etc. Dr. Perey and Dr. Brown have held initial meetings with HLC in preparation for the initiative implementation.

General Comments:

- Included in the board packet was the most recent research from Moody's Investor Services outlining their findings as a stable credit rating for the College's A2. This report is another indication of the stability of the college. This coupled with the recognition from the Government Finance Officers Association for Excellence in Financial Reporting for the FY'21 Annual Comprehensive Financial Report demonstrates careful stewardship of taxpayer dollars.
- Each board member received a letter via email from Dr. Ceci Lewis, Faculty Emeritus at Cochise College with her request to initiate a name change for the college mascot. In conversation with Chair DiPeso, Dr. Rottweiler brought it to the board seeking direction on next steps. The president states the "Apache" mascot has been associated with Cochise College since the first year of the college. The college has worked diligently to present the "Apache" mascot in a culturally sensitive way. There is no usage of "Apache" caricatures on uniforms, memorabilia, or communications. Historically, the "Apache" name has been associated with the great Chiricahua Apache leader, Cochise, and the county and college are named in his honor. The decision was made by the college board in early years. Dr. Rottweiler sought direction from the Board:
 - Mr. DiPeso sees it as a sign of respect to the Apaches' fighting spirit matching that of the college; and notes no action is needed.
 - Mr. Quinn states no action is needed at this time.
 - Mr. Hudgins does not want to change anything nor has any desire to change it.
 - Mrs. Strain wants no part of the conversation.

- The College received a letter from the Government Finance Officers Association notifying the college that the comprehensive annual financial report (CAFR) for the fiscal year ended 2021, qualifies for GFOA's Certificate of Achievement for Excellence in Financial Reporting, which is the highest form of recognition in governmental accounting and financial reporting, and its attainment represents a significant accomplishment.

3.02 Directed Self Placement Report

Angela Garcia, Dean of Liberal Arts, and Ella Melito, English Faculty and Department Chair, provided a presentation on Directed Self Placement; highlights include:

Introduction to Directed Self Placement (DSP):

- A presentation at Arizona Transfer Foundation (ATF) led by Dr. Toth
- Two key sources:
 - Presentation by Dr. Christie
 - TYCA White Paper on Placement Reform
- Early April 2020, the Cochise College English Department contacted the University of Arizona (UA) writing program in response to the pandemic
- Most salient feature initially was the entire process is completed online, addressing immediate need for accessible, remote placement.
- Cochise implemented the Reading and English DSPs three months later in June 2020
- Research relevant to the DSP college began long before pandemic, mathematics professional learning council at the college showed that students who signed a waiver to get into College Algebra were 80% more likely to pass the course than their peers who were placed into it.
- Full-blown placement reform effective May 2022 when the math department implemented their own DSP.
- All three content areas are now using Qualtrics, a robust survey tool, to allow students access to the DSP surveys and to facilitate data collection.

How DSP Works:

- Course Descriptions
- Videos: Content and Rigor
- Self-Assessment
- Course Recommendation
- Final Course Selection
- Overview of how DSP works.
 - Students place themselves into the course level of choice with guidance and information about college-level expectations.
 - DSP videos feature Cochise College instructors.

- Self-assessment activities and questions requiring students to consider their; experiences in previous course content, learning preferences/styles, and confidence in their college readiness.
- Recommendation for the initial course based on the self-assessment.
 - 34% are placing themselves are not following recommendations and 40% of those are choosing a lower level.

- Provides a glimpse into factors that cannot be measured by standardized test scores

- Mitigates disproportionate placement

Questions/Comments:

Mr. Quinn noted his appreciation for the briefing. Responding to Mr. Quinn, Dean Garcia noted that prerequisites have been reviewed; math went to pathways, deceased developmental math levels from three to two, and labs were imbedded into college-level math classes.

Mr. Hudgins expressed his appreciation of changing challenges and turning them into opportunities to succeed.

Dr. Rottweiler noted that the next step is to merge CPD and the DSP providing all opportunities for success. He recognized the work of Abe Villarreal, Angela Garcia, and Ella Melito and their willingness to take a risk to run a pilot.

3.03 Community Engagement Report

Dr. Jennifer Wantz, Executive Dean of Community Engagement, provided a presentation on Community Engagement Initiatives, Cochise Cares, and facility rental updates; highlights include:

Facility Rentals:

- Dr. Wantz noted that sales and facility rentals decreased during the pandemic; however, the department is seeing significant strides as of FY22.
- Sales in FY19 equaled about \$30,000; Sales in FY22 equaled a little over \$20,000, which is not where the department was before COVID-19, but making changes to bounce back.

Questions/Comments:

Responding to Mrs. Strain regarding a linkage between Cochise Cares and nonprofit organizations in the community, Dr. Wantz stated it is hard to know the direct linkage, as the information has not been tracked before. However, Cochise College staff and students are part of many community services and there is a linkage with all the varied opportunities.

Mr. Quinn noted that many members don't just attend meetings, they are also involved; it is more community enrichment rather than just community engagement.

3.04 Revised Governing Board Policy 301 – Delegation to the President

Revised Governing Board Policy 301 – Delegation to the President, was presented as a review and second first read. The policy was brought before the board for review and discussion following recommended changes per Board Member Quinn. Mr. Quinn worked with Dr. Davis on the revisions, which include increasing contracts for architectural services from \$50K to \$100K; construction contracts amount from \$100K to \$250K; Leases from \$100K to \$200K; and other procurement contracts from \$250K to \$350K. Mr. Quinn noted that the president shall follow the legal and ethical decisions and directions of the board.

With no additional recommended changes, the policy will be presented during the October meeting for second review and approval.
