2.01 Guaranteed Maximum Price #2 – Sierra Vista Campus Housing

The administration is requesting the Governing Board adopt a motion to accept the Guaranteed Maximum Price proposal #2 for the Housing provided by CORE Construction in the amount of \$9,867,657 and an overall cost of the balance of the HOU project in the amount of \$11,249,129. With approval of this recommendation, the total project cost is set at \$14,864,625 (including both GMP#1 and GMP#2).

The administration is requesting the Governing Board adopt a motion to accept the Guaranteed Maximum Price proposal #2 for the Firearms Training Complex (FTC) provided by CORE Construction in the amount of \$6,328,137 and an overall cost of the balance of the FTC project in the amount of \$7,087,514. With approval of this recommendation, the total project cost is set at \$12,260,563 (including both GMP#1 and GMP#2).
